

Light Motor Vehicle Tax

The light motor vehicle tax “*Kei Jidoshazai*” is a tax levied each year on individuals recorded (on the base date of April 1 of the year) as owning a motorbike, light motor vehicle (660cc or under), special small-sized motor vehicle, or two-wheeled mini-car.

■ Tax amount and place to perform related procedures

Key:

MITD = Municipal Inhabitant Tax Division (Ota City Hall)

GUS = Gunma *Unyu Shikyoku* (Gunma Transport Bureau Branch Office)

Motorbikes, Two-wheeled Vehicles, etc.

| | Mini-car | ¥3,700 | City Hall, 2F, Counter 22 of MITD |
| Special small-sized motor vehicle | Agricultural purpose | ¥2,400 | City Hall, 2F, Counter 22 of MITD |
| | Others | ¥5,900 | City Hall, 2F, Counter 22 of MITD |
| Two-wheeled light car | 250cc or less | ¥3,600 | ※ GUS |
| Two-wheeled mini-car | Over 250cc | ¥6,000 | ※ GUS |

- ① Notifications (of “Gunma” number plate vehicles) indicated by the mark “※” cannot be processed at Ota City Hall.
- ② Since this is not a monthly-installment taxation, even in cases of changes of ownership and vehicle disposal after April 1st, the taxpayer (for the vehicle) and taxation amount for that fiscal year will not change.

■ Procedures involved with motorbikes and special small-sized motor vehicles (with Ota City number plate)

※ Furthermore, those with environmentally friendly vehicles (electric cars, cars that have achieved the fuel efficiency standard, etc.) may receive 25~75% reductions in their tax rate after registering their car. (For only one year, however)
