# Information on the Fourth Dose of COVID-19

The fourth dose of the vaccine is available to persons 60 years of age and older, and to persons

between 18 and 59 years of age who have an underlying medical condition. For those 60 years of age or older, the fourth vaccination ticket will be sent approximately five months after the third vaccination, but for those 18 to 59 years of age with an underlying disease who wish to be vaccinated, it is necessary to submit an application form in advance, however, those who have already applied for the first and second vaccinations as those who have underlying medical conditions do not need to reapply this time.



## Eligibilities: those who receive treatments in a hospital or hospitalized for the following illnesses, etc.

- 1. Chronic respiratory disease
- 2. Chronic heart disease (including high blood pressure)
- 3. Chronic kidney disease
- 4. Chronic liver disease (cirrhosis, etc.)
- 5. Diabetes being treated with insulin or oral medication, or diabetes associated with other diseases
- 6. Blood diseases (except for iron deficiency anemia)
- 7. Diseases that reduce the function of the immune system (including malignant tumors that are undergoing treatment or palliative care)
- 8. Receiving treatments that decrease the function of the immune system, including steroids
- 9. Neurological or neuromuscular diseases associated with abnormalities of immunity
- 10. Neural or neuromuscular diseases that result in reduced bodily functions (including breathing disorders)
- 11. Chromosome abnormality
- 12. Severe mental or physical disabilities (a combination of severe physical disability and severe intellectual disabilities)
- 13. Sleep apnea syndrome
- 14. Serious mental illnesses (hospitalized for treatments of mental illnesses, or holding the Mental Disability Certificate "Seishin Shogaisha Hoken Fukushi Techo," or falling under the category of "severe and continuous" in medical care for services and supports for persons with disabilities (outpatient mental health care)) or intellectual disabilities (holding the Medical Treatment and Education Handbook "Ryoiku Techo")
- 15. BMI of 30 or more
- 16. Admitted by a physician as having a high risk of serious illness in case of COVID-19 infection.

### Application Procedure

Applications are accepted at the counter, by mail, fax, or via the Gunma e-Application system. No medical certificate or other certification is required at the time of application, but please consult with your primary doctor well in advance.

The information is published in anticipation of the revision of the Immunization Act. In addition to those who have not yet been vaccinated and those who have received the third dose, an overview of the fourth dose and various schedules will be provided.

# 3rd and 4th doses

### 3<sup>rd</sup> Vaccination

Vaccination is given 5 months after the completion of the 2<sup>nd</sup> vaccination.

#### 4<sup>th</sup> Vaccination

Eligibilities: One of the following persons for who had their 3<sup>rd</sup> doses at least 5 months ago

(1) Over 60 years old or older (2)\* 18-59 years old with underlying disease

(3)\* 18 to 59 years of age and at high risk of severe disease if exposed to COVID-19, as recognized by a doctor.

To those who fall into categories (2) and (3) above.

Please apply if you wish to be vaccinated.

(Those who have applied for the 1st and 2nd vaccinations do not need to do so.)
