COVID-19 Vaccination Certificate for Overseas Travel

Application has started from July 26, 2021 (Mon.).

Vaccination certificates will be issued to officially certify that you have been vaccinated against COVID-19, so that other countries can use it to determine whether or not to relax quarantine measures when you travel.

What is a Vaccination Certificate "Sesshu Shomeisho"?

The certificate is issued upon application from the vaccinated person as official proof that the vaccination against COVID-19 was conducted in Ota City based on the Immunization Law.

Who can apply?

Vaccination certificates are issued to those who meet both of the following:

- Those who have received the vaccination against COVID-19 using a vaccination coupon / ticket issued by the city or a Pre-vaccination Screening Questionnaire with a vaccination coupon / ticket.
- Those who need to present a certificate due to circumstances such as overseas travel.

The following persons are not eligible for issuance.

- Those who have not actually received the vaccination due to age or other reasons.
- Those who do not intend to travel abroad.
- Those who have received vaccinations outside Japan, etc.

How to apply

Please apply in one of the ways below. It takes approximately one week to be issued after the application is received.

Note 1- If you moved to a different municipality after your vaccination, or if you received your first and second vaccinations using a different municipal vaccination coupon / ticket, the respective municipality will be the place to apply.

Note 2- There is no application fee, and one certificate can be issued per application.

What you need


- (1) Application Form for Vaccination Certificate of COVID-19 (18KB)
- (2) A passport valid for international travel*1
- (3) Certificate of Vaccination for COVID-19 "Sesshu Zumisho," Vaccination Record Certificate "Sesshu Kirokusho" (for medical personnel), or a copy of the Pre-vaccination Screening Questionnaire "Yoshinhyo" (Copy for recipient)
- (4) Original or copy of I. D.
- (5) Return envelope (optional for counter applicants)²



- *1 The passport number on the Vaccination Certificate must match the passport number used for international travel. If your passport number changes after you have received your Vaccination Certificate, you will need to obtain a new certificate. If you are in the process of applying for passport issuance, please apply for the certificate after your passport is issued. Applications can also be made for passports issued by foreign governments, such as those of foreign nationals.
- *2 Please write your name and address, and attach a stamp.

Documents required in some cases

- If your passport shows your maiden name or alias (in English); Identification documents that can confirm your maiden name or alias (Individual Number Card, Driver's License, etc.)
- In the case of a request by proxy Power of Attorney (8KB) signed by applicants. I.D. of the proxy (Resident "Zairyu" Card, Individual Number Card, Driver's License, etc.) *

*If you apply by mail, please submit copies of the required documents (2) (3) (4).

Points of Concern

- If you do not plan to travel overseas, we cannot issue a vaccination certificate. Please use the certificate of vaccination "Sesshu Zumisho" in Japan.
- The name on the certificate must match the name on the passport. If you wish to use a different name, please correct the notation on your passport in advance.
- Please note that it may take some time to issue the certificate after receiving an application.
