

Or mid-year enrollment for parents / guardians who will finish their maternity or childcare leave and wish to use childcare services in FY2022

Eligible children: Both infants and their parents / guardians must live and be registered in Ota City and infants are able to be taken care of in a group setting. (infants 9 weeks - before their 1st year of elementary)

Conditions to use childcare services: Parents who are unable to take care of their children at home because of one of the reasons below

- ●Work outside of home ●Work at home (e.g. self-employed, farming, working a side job); excludes housework
- Pregnant mothers or mothers who have given birth recently (8 weeks prenatal; 8 weeks post childbirth; or approximately within a five month period)
- Those with an illness, injury, or mental / physical disability Nursing / taking care of a sick / disabled family member in regular basis
- In midst of restoring home after damage from fire, wind or floods, earthquake, or other disasters
- Parents who are seeking employment (including those who are preparing to open a business)
- Parents who are receiving either schooling or vocational training A victim of domestic violence (DV) or abuse **Childcare hours:** Available for parents who require services; must be within the childcare's operation hours.

How to apply: Submit your application form with required documents at the application venue below. Please check for changes (including location, hours) on the city's website.

Application periods (excludes weekends and public holidays), hours and locations:

- 1- October 19 (Tue.) 29 (Fri.), 2021, 9:00-11:30 / 12:30-16:00, at the meeting room "Dai Kaigishitsu", City Hall (3F near counter 31)(The result will be sent in mid-December by post.)
- 2- February 1 (Tue.) 10 (Thu.), 2022, 8:30-17:15 at the Children's Affairs Division "Kodomo-Ka", City Hall (3F / counter 31) (The result will be sent in early March by post.)

\*Admission decisions are not decided by the order of the applications. \*Applications are NOT accepted at nurseries.

\*The first and last days of the application periods are expected to be crowded. Please avoid those days if you can and bring as few people as possible to the application center. Vaccination Period: Until January 10th (Monday / Public Holiday), 2022

**Eligibility:** Applicants who registered in the city on the vaccination day and meet any of the conditions in the table below. **Number of Vaccination:** Once (Twice for individuals who are under age of 13 and have severe disability)

**How to receive:** Bring your vaccination form at a medical facility conducting vaccination.
