An application must be submitted every year!

For parents / guardians of elementary and junior high school students

System Details

Your **second-born onward** will be **exempt** from paying school meal fees.



1st child

※ Under 20 years old.



2nd child onward

100% exemption!

Conditions (must apply to all conditions)

- Must be taking care of **2 or more** children born on / after April 2nd, 2001.
- Must **reside within Ota City** (includes individuals planning to move to Ota)
- Ota municipal taxes must all be **accounted for and paid**.
※ If you have any unaccounted taxes, please consult with the division in charge.
- ※ Second-born onward students enrolled in **municipal elementary schools and junior high schools (excludes Ota Chugakkou)** will not be claim for school meal fees in order to subsidize.
- ※ Students **enrolled in Ota Chugakkou, schools outside the city, private schools, and prefectural schools for special education needs** will receive the same amount of municipal subsidies as other municipal schools for school meals around March 2022 in the form of Ota-Shi cash vouchers.

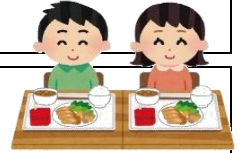
How to Apply

① Complete form

- Please fill out the sections 1, 2, and 3 of the consent form (right page) and follow the sample.
- The applicant (parent/guardian) must write their name and stamp their personal seal "Inkan" (self-inking seals "shachihata" not accepted)

② Send

- Please use the return envelope enclosed with the application (stamp not required)
- Since this pamphlet is sent to all applicable individuals, you may have several copies. Please send and fill out one for everyone per household.
- Please fill out section 3 after carefully reading and understanding the calculation method for subsidy.



③ Results

- Your application results will be sent through post mail
- You will start receiving subsidies the month it has been approved.
- Applications submitted past the deadline will be decided in the next month after the application submitted, in principle.

※ Other documents may be required depending on content of your application.
