Current National Health Insurance Card will expire on September 30 (Wed.) 2020

Renewing National Health Insurance Card

New health insurance cards (valid from October 1, 2020) will be sent in late-September. Please check that your details are correct when you receive them. % Please dispose of your old insurance cards, or return to the National Health Insurance Division (Ota City Hall 1F / counter 16), Community "*Gyosei*" Centers (excluding Ota Community Center), or East / West Service Centers when they expired.



National Health Insurance Card's Validation

In general, the expiry date of the National Health Insurance Card is on September 30, 2021, however, here are exceptions.

① Individuals who are 75 years old or above are members of the Medical Insurance System for Older Senior Citizens, so the expiry date for the card is a day before their 75 years old birth day.

2 Individuals who are foreign nationals with a period of stay that expires before September 30, 2021. The expiry date of the card is a day after the expiry date of your stay.

Withdrawal

If you join your company's health insurance program, or become the dependents of someone who has, you need to complete the procedures to withdraw from the National Health Insurance program.

National Health Insurance Tax

Members of the National Health Insurance are responsible for the National Health Insurance Tax. If you fall behind in payment without special circumstances, such as a disaster, you are issued with the "Health Insurance Qualification Certificate" instead of the National Health Insurance Card. If you have medical treatments with the certificate, you need to pay the full amount (100%) of the cost. You can be reimbursed for your insurance benefits at a later date if you apply for it. Please feel free to come for consultation about the payment and seek advice.

Group Dog Vaccination for Rabies is CANCELLED.

Please have your dog vaccinated individually (which needed to be done every year) at a veterinary clinic or other facility by December 31, 2020 (Thursday).

What to bring: Rabies' vaccination notice (notice will be sent to dog owners who has registered at the city but have not been vaccinated in this fiscal year.) Note: Procedures are needed if your dogs are vaccinated at veterinary clinics that are not members of the Gunma Veterinary Medical Association.
