Assistance for School Meals and Childcare Available

Requirements for all the Assistance below

- Applicant and eligible children must have an address in Ota.

-Applicant and all of their household members must all be enrolled in medical insurance.

-Municipal taxes, etc. must be paid and up to date (%Please consult your respective division if you have unpaid taxes.)

Assistance for School Meals at Kindergartens, etc.

2nd Child: 50% Subsidy, 3rd Child onwards: Full Exemption

Requirements (need to be met both 1 and 2)

1-Raising 2 or more children born on / from April 2, 2000 (1999 for childcare centers outside of the city) onwards in a household

2-Children who are entering public / private kindergartens, early childhood education and care centers, certified childcare facilities this coming April (Type 2 is for *Nensho* class or over.)

How to apply: Applications are distributed at childcare centers. Fill out and submit applications at your respective kindergarten, etc.

Children who went to childcare centers outside the city: Reimbursement application forms have already been sent for FY 2019. School meal fees for April onwards will also be sent around the same time in next year.)

Application Period: until February 21 (Fri.) (excludes weekends and public holidays)

Things to bring: applicant's Resident "Zairyu" Card, photocopy of applicant's health insurance card and "Inkan"-seal.

- * If you are living separately from your child (separate custody), additional documents may be required to submit.
- * Applications to receive Birth Money "Shussan Iwaikin" for the 3rd child onwards are accepted at any time. Please visit the city website for details.

Fees for Lunch / Bentos at Child Development Support Centers

2nd Child: Maximum 2000 yen per month, 3rd Child: Maximum 4000 yen per month

Lunch / bentos paid for during April 1, 2019 to March 31, 2020 are covered.

Requirement: Raising 2 or more children born on / from April 2, 1999 onwards

<u>Things to bring:</u> Application form, copy of health insurance of all household members, receipts that show paid meals, billing statement (for those that brought in *bento*), "Inkan"-seal.

<u>How to apply:</u> Follow the instructions on your application to who have the recipient certification (yellow) in March onward, and mail / bring in that and required documents to Disability Welfare Division. (Ota City Hall 1F)

Properly Enroll in National Health Insurance

The National Health Insurance (*Kokuho*) benefits those who are self-employed, employed in agriculture, and individuals in companies who do not offer health insurance. It also provides insurance for unemployed individuals.

Individuals who are currently enrolled in National Health Insurance may also be recognized as a dependent of their family's Social Health Insurance or Health Insurance Association if certain conditions are met. The conditions (dependents' annual income, relationship with the person enrolled in Social Health Insurance, living arrangements, etc.) for acceptance may differ according to their place of employment. Please consult with their place of employment.

Please proceed with the withdrawal of your National Health Insurance at Ota City Hall if you are already enrolled in your employer's health insurance.

Places to enroll: Ota City Hall – National Health Insurance Division (1F/ Counter 16), East and West Service Center, or a select Community "Gyousei" Center (excludes Ota Community "Gyousei" Center).

Eligibility: Individuals who are issued a Social Health Insurance Card and still possess a National Health Insurance Card.

Things to bring: both insurance cards, *inkan*-seal and I.D. (Resident *Zairyu* Card, driver's license, etc.), Individual "*My Number*" card **For more information:** Ota City Hall – National Health Insurance Division "*Kokumin Kenkou Hoken-Ka*" **2**0276-47-1825

Filling Final Income Tax Return

The declaration of Income Tax "*Kakutei Shinkoku*" is a procedure by which tax payers file a final income tax return on income earned during the period from January to December of the previous year for making final calculation of income tax. Please file it as early as possible and do not miss the deadline.

Required to file a final income tax return:

- Individuals who have income from business, agriculture, real state, etc. between Jan. 1 and Dec. 31 in 2019, and the tax amount calculated after subtracting the total of basic exemption and other deductions from total income exceeds the sum of credit for dividends, etc.
- Individuals with earning from employment income exceeding ¥20,000,000.
- Individuals who have employment income and have income with the total amount from various income (excluding retirement income) that exceeds ¥200,000.

Not required to file a final income tax return:

- ■Individuals who do not have any other income besides salary and wages from a company and they perform the year-end adjustment of tax deducted at source "Nenmatsu Chousei."
- ●Individuals whose total amount of earnings from public pensions or other sources is ¥4,000,000 or less and the amount of income besides miscellaneous income from public pensions and other sources is ¥200,000 or less.
- *Recipients of public pensions, etc. that are not subject to withholding tax are not eligible for this.
- If you receive deductions that require a refund of income tax or submission of a tax return (deduction for carryover of net loss, casualty loss, etc.), you must file your final income tax return.

- *Consultation services may finish before closing time due to over crowdedness. (It is expected to be particularly crowed and busy on the first day.)
