Applying for Childcare Facilities 2020 Fiscal Year

Eligible persons to apply: Parents / guardians who wish to use childcare services from April 2020

Or mid-year enrollment for parents / guardians who just finish their maternity or childcare leave and wish to use childcare services in FY2020

<u>Eligible children</u>: Both infants and their parents / guardians must live and be registered in Ota City and be able to be taken care of in a group setting. (infants 9 weeks ~ before their 1st year of elementary)

Conditions to use Childcare services:

Parents who are unable to take care of their children at home because of one of the conditions below

- Work outside of home Work at home (e.g. self-employed, farming, working a side job, etc.); excludes housework
- Pregnant mothers or mothers who have given birth recently (8 weeks prenatal; 8 weeks post childbirth; or approximately within a five month period)
- Those with an illness, injury, or mental/physical disability
- Nursing/taking care of a sick or disabled family member in regular basis
- In midst of restoring home after damage from earthquake, wind or floods, fire, or other disasters
- Parents who are seeking employment (including those who are preparing to open a business)
- Parents who are receiving either schooling or vocational training
- A victim of domestic violence (DV) or abuse

<u>Childcare hours</u>: Available for parents who require service; must be within the childcare's operation hours.

Application periods (excludes weekends and public holidays):

1st Application Period: October 11 (Fri.) ~ 29 (Tue.), 2019 (The result is sent in December by post.) 2nd Application Period: February 3 (Mon.) ~ 14 (Fri.), 2020 (The result is sent in March by post.)

(The application process is not first-come-first service.)

Submit forms with required documents at City Hall, 3F the meeting room "Dai Kaigishitsu" behind counter 31.

<u>Applications are NOT accepted at Children's Affairs Division or childcare facilities.</u>


