

If women in early stages of pregnancy without antibodies against rubella contract the virus, there is a possibility their child may suffer from heart disease and hearing loss due to congenital rubella syndrome. Due to this fact, fees for rubella vaccinations (adults) will be partially subsidized.

Eligible persons: residents registered in Ota City on the day of vaccination, and apply to one of the following below:

(1) Women planning pregnancy, and/or their husband/partner (2) Husband/partner of pregnant woman

* Individuals who have clearly had rubella in the past or have already received 2 doses of rubella vaccination, women currently or possibly pregnant, and individuals who have already received the benefit after the 2013 fiscal year are not eligible.

Subsidy amount: ❖Rubella-only vaccination: ¥3,000 ❖ Measles-Rubella Combined (MR) vaccination: ¥5,000 (This subsidy is limited to one dose of either vaccination per person.)

Period for subsidized vaccinations: April 1st, 2017~ March 31st, 2018

Enrollment/Cancellation of National Health Insurance

The National Health Insurance "Kokuho" is for individuals that are self-employed, agricultural workers, not employed or covered by their employer's insurance, or enrolled in some form of medical insurance program. National Health Insurance premiums will be levied retroactively if your enrollment is late. If you are late with canceling your National Health Insurance, you will continue receiving insurance premium bills; in the case you use your national health insurance card after losing validity, you will be responsible for refunding all fees covered by the National Health Insurance.

Enrolling into National Health Insurance

In cases when you lose your Social Insurance "Shakai Hoken" after retiring or quitting, you must enroll in National Health Insurance. Please bring the following documents.

- 1) Social Insurance Withdrawal Certificate "Shakai Hoken Ridatsu Shoumeisho"
- 2) Seal-Inkan (stamp-type seals not accepted)
- 3) Identification: Resident "Zairyu" Card, driver's license, etc.
- 4) Individual Number Card or My Number Notification

Canceling National Health Insurance

You must cancel your National Health Insurance if you start enrolling in your employer's health insurance. Dependents must also cancel if they are covered by an employer's insurance program. Please bring the following documents.

- 1) Health insurance card provided from their employer
- 2) National Health Insurance card
- 3) Seal-Inkan (stamp-type seals not accepted)
- 4) Identification: Resident "Zairyu" Card, driver's license, etc.
- 5) Individual Number Card or My Number Notification
