It is possible to purchase electricity from companies that have received the liberalization registration from the country. The consumers can adjust the services according to their lifestyle with the diversity of services to choose from such as; rates, options and discounted packages of electricity and gas combined and others.

The companies that sell electricity are obliged to explain the electricity rates and terms of cancellation. Therefore, ensure to fully understand the content of the contract before signing it. NATIONAL PENSION SYSTEM "KOKUMIN NENKIN"

All registered residents of Japan from 20 years old must be covered by the National Pension system regardless their nationality. The insured are categorized according to their status as follows:

The contribution amount for the National Pension of 2016 Fiscal Year is ¥16,260 per month. (Increase of ¥670/monthly from April 2016 onward.)

Contribution Exemption System: When your income is too low to pay the contributions or you have other reasons, you can apply for the exemption from contribution payment at your local Municipal Office.

National Pension System Types: Old-age Basic Pension "Rourei Kiso Nenkin", Disability Basic Pension "Shougai Kiso Nenkin", Survivor's Basic Pension "Izoku Kiso Nenkin"

SPECIAL PAYMENT SYSTEM FOR THE NATIONAL PENSION FOR STUDENTS

It is mandatory for the students who are 20 years old and above to enroll into the National Pension System "Kokumin Nenkin". However, if you are a student and your income is less than a certain amount, you may be allowed to postpone the contribution payment by applying for the Special Payment System for the National Pension for students.

If your application is approved, you will be enrolled into the system. Therefore, between the period of April of the current year to March of the following year you will be exempted from the contribution payment, in case of continuing attending the same educational institution, you will only need to fill out the application sent through the postal mail by the Japan Pension Service "Nihon Nenkin Kikou", in order to establish the exemption you will need to apply for it every year (from April of the current year to March of the following year). Note that some educational institutions do not apply for this system

1) Only the student's income will be inspected.

2) In case of getting injured during the grace period for the contribution payment, it is possible to receive the basic Disability Pension depending on your situation.

neumococcal Preventive Vaccination for Senior C

Please read the Vaccination Notification and Explanation form thoroughly and receive the vaccine within the period mentioned below.

Inoculation Period	Until March 31, 2017.
Number of doses and cost	1 dose (2,000 yen) ※Eligibility limited for one time only.
Eligible age for the fiscal year of 2016	Persons who have the Resident Record registered within Ota City on the day of the inoculation and whose age are: 65, 70, 75, 80, 85, 90, 95 and 100 years old (by March 31, 2017). (A notification and medical application will be sent)
How to apply	 Take the vaccination form to your primary care physician. Please consult if your primary care physician is located on the outskirts of Ota City. We recommend that you contact your doctor if it does not fit the age for vaccination on the fiscal year of 2016, but feels that it is necessary to receive this vaccination.

The persons who are at the age of 60 years old up to 64 years old will be considered eligible for the Pneumococcal Preventive Vaccination for the Senior Citizens with a particular functional; disturbance in the heart, kidney or respiratory function due to human immunodeficiency virus (HIV). In such cases consult your doctor and if you want to receive this vaccination, please contact the Public Health "Hoken" Center to receive the Medical Questionnaire needed.

Those who already have received the Pneumococcal Preventive Vaccination (PPSV23, Pneumovax NP) in the past are not eligible.

The adults Rubella Preventive Vaccination will be partially subsid

Women in early stages of pregnancy especially who have not developed immunity to this disease are at risk of contracting it and giving birth to babies with congenital rubella syndrome, leading to heart disease, deafness and others. Ota City consequently is taking the emergency measure of partially subsiding the fee for adult residents to get vaccinated against rubella.

→Eligibility: Must be residents of Ota City on the day of vaccination and be eligible to one of the following options below: ① Women planning to become pregnant and their husbands/partners. ② Husbands/Partners of pregnant women.

* Persons who clearly have had rubella in the past or who have already received 2 doses of the rubella vaccination, women currently pregnant or who are possibly pregnant and persons who already received the benefit during the period (fiscal year) of 2013 ~ 2015, are not eligible.

Amount of subsidy: ✓ Rubella-only vaccination: ¥3,000 ✓ Measles-Rubella Combined (MR) vaccination: ¥5,000 (The subsidy is limited to one time and to either one of these doses.)

→Period of subsidized vaccinations: April 1, 2016 ~ March 31, 2017

* In person or by phone, request the medical form directly at any Public Health "Hoken" Center:

* Please present the medical form to the medical facility where you are receiving the vaccine.

* Please pay the remaining amount to the medical facility after the subsidy portion has been deducted.

* The medical form can be downloaded from Ota City's homepage.

Please consult with your primary care physician if the medical facility is located on the outskirts of Ota City.
