### Mailing the Certificate of Tax Payment "Noufu Gaku Shoumeisho" for the National Health Insurance "Kokumin Kenkou Hoken"

Ota City Hall will mail the Certificate of Tax Payment "Noufu Gaku Shoumeisho" on January 22, 2016 (Fri.) to the heads of household who are subscribed to the National Health Insurance "Kokumin Kenkou Hoken".

This certificate (in the form of a postcard) shows the total tax amount paid from January 1 to December 31, 2015. It is necessary to have it when filing for deduction of your final income tax and Municipal and Prefectural Inhabitant Taxes.

### Beware of "Gold Scam"!

"My wife who is a foreigner is receiving some invitations from a friend to make some money by investing in gold as well as the recruitment of others. However, we did not understand how it works. Should we trust this company?" A friend told me that I could earn some money by investing in buying gold. Also, I could multiply my profits in a few months if recruiting others. So, I decided to give it a try. However, I did not receive a contract so I got worried. Therefore, I decided to cancel it and requested to have a refund, but they are not replying to my request.

Let's be aware of scams through invitations to invest in purchasing/selling gold targeting the foreign nationals. Customer Service Centers cannot confirm the reliability of these companies, and if it is a Multi-Level Marketing System (also known as MLM), it is subject to follow the regulations listed by the specific commercial transaction of this country. In addition, if the product is not included in the deal, it could be linked to the "Pyramid Scheme," which is prohibited by law. Moreover, the Japanese's law does not apply if it is a company abroad which can cause difficulties to get your money back.

Although, beware of the dangers of signing a contract only thinking about the profit you could make immediately. There is no profit guarantee on these businesses. Therefore, be very skeptical when you are told things such as; "Anyone can do it," "It is an easy way to make money" and "It is lucrative." Be conscious and aware of the risks before signing a contract. Also, refuse firmly the invitations even if it is from friends or acquaintances.


## Assistance Child-Rearing Program for the 3rd Child Onward

From April, 2016 onward, we will be accepting applications for exemption of childcare fees and subsidy for school meals for the households raising their 3rd child. X The persons who have already applied for the Assistance Program, will be receiving the application form by postal mail at the beginning of January.

Application Period: From January 13 (Wed.) ~ February 12 (Fri.) (except weekends and holidays) % Those who are applying for the exemption of Authorized Childcare Center Fees, please follow the information shown on the Childcare Admission Acceptance Letter "Hoikuen Nyuuen Shoudakusho." Conditions for Applying: For applying to this program, all of the following conditions need to be met:

- Must be living in the same household and be raising 3 or more children, all born from April 2, 1996 onward (those who go to private Kindergartens on the outside of Ota City must be born from April 2, 1995 onward);
- Parents and children need to be registered as residents in Ota City for more than 1 year;
- The applicant and all the other household members should be registered as full members or dependents of the health insurance system of this country;
- •The parents have no unpaid municipal taxes and others (Municipal and Prefectural Inhabitant Tax, Fixed Property Tax, Light Vehicle Tax, National Health Insurance "Kokumin Kenkou Hoken" Tax, monthly childcare fees, kindergarten tuition, elementary or junior high school meal fees, rent and other fees for municipal housing, etc.). X The conditions may change if the child applying is less than 3 years old and he/she requires to be enrolled to a childcare facility or to an authorized center for early childhood education and care. Therefore, please consult the Children's Affairs Division "Kodomo-Ka" (2F) at Ota City Hall.
