Full Exemption for Childcare Fees for 3rd Child onwards from April 2023

For those already receiving assistance need to follow the instructions on your application sent. For children who are in *Nensho* class or over, no application is required due to the free system for preschool education and day-care services.

Application Period: until February 17th (Fri.), 2023 (excluding weekends and public holidays)

Things to bring: Benefit Approval Certificate "Shikyuu Ninteishou"

Eligibilities: Must meet all of following

- ■Raising 3 or more children (excluding who are married)
- ●Both applicant (parent / guardian) and their applicable child have an address in the city
- Applicant and their member(s) of household have joined a medical insurance
- No arrears on taxes or other payment(s) (including municipal inhabitance tax)

The degree of disability and requirements for eligibility (below) are approximate. Please check with the Disability Welfare Division (Ota City Hall, 1F) for details as there may be restrictions on benefits such as income limits. (Note: The monthly figures are for FY 2022.)

Special Child-Rearing Allowance *"Tokubetsu Jidou Fuyou Teate"*

Eligibilities: Parents taking care of a child under 20 years of age who meet one of the following requirements, or those who are taking care of a child on behalf of the parents

Level 1 (52,400-yen / month):

- Physical disability equivalent to Level 1 or 2 of the Physical Disability Certificate "Shintai Shougaisha Techou"
- Intellectual disability equivalent to Grade A in the Medical Treatment and Education Handbook "Ryouiku Techou"
- Mental disability equivalent to Level 1 of the Mental Disability Certificate "Seishin Shougaisha Hoken Fukushi Techou"

Level 2 (34,900-yen / month):

- Physical disability equivalent to Level 3 of the Physical Disability Certificate "Shintai Shougaisha Techou"
- Intellectual or mental disability that significantly limits daily life



Eligibilities: 20 years of age or older who meet all of the following requirements (Internal disabilities "Naibu Shogai" only are not eligible.)

- People with extremely severe disabilities who require special care in their daily lives
- People who have not been admitted to a social welfare institution
- People who have not been in a hospital for more than three months

Disabled Child Welfare Allowance "Shougaiji Fukushi Teate" (14,850-yen / month)

Eligibilities: Under 20 years old who meets all of the following requirements (can be paid together with special child-rearing allowance)

- People who need constant care in their daily lives
- People who are not in receipt of disability benefits
- People who have not been admitted to a social welfare institution


