# **Intensive/Focused Support Benefit** for **Soaring Prices** in **Staples** and **Utilities**

Notifications have been sent to eligible households in order from late-December 2023. Benefit amount: **70,000-yen per household** 

**Eligibilities:** Households with an address in the city as of **December 1, 2023**, and all members of the household are exempt from the per capita rate of inhabitant taxation, *Jyuuminzei Kintouwari Hikazei Setai*, for the fiscal year 2023, *Reiwa 5 Nendo*.

\* For those who are eligible but have not received a notification, please contact the call center (20276-49-5735) as an application may be required.

# FY 2023 Ota City (100,000-yen / Household, 50,000-yen / Child) Benefits for Supporting Financial Wellbeing through Cost-of-Living Hikes

- 1. Eligibilities / Must meet both (1) and (2):
- (1) Those with a registered address in the city as of the base date (December 1, 2023).
- (2) [1] Benefits for households taxed ONLY at the per capita rate of inhabitant tax

  All members of the household are exempt from the income rate of inhabitant taxation,

  Jyuuminzei Shotokuwari Hikazei Setai, for the fiscal year 2023, excluding those households

  exempt from the per capita and income inhabitant taxation for the fiscal year 2023.

#### [2] Additional benefits for children

Households with children 18 years old or under (born between April 2, 2005 and March 31, 2024) in which all members of the household are **exempted from the income rate of inhabitant taxation**, *Jyuuminzei Shotokuwari Hikazei Setai*, for the fiscal year 2023.

Note: Households consisting solely of dependents of the taxpayer are not eligible for those benefits.

- 2. Benefit amount: [1] 100,000-yen per household [2] 50,000-yen per child
- 3. Application:

**Notification will be sent to your address** for households which received the Intensive / Focused Support Benefit for Soaring Prices in Staples and Utilities (70,000-yen / household) in this fiscal year, OR households which all members are registered as residents in the city (as of January 1, 2023) and have been confirmed to meet the requirements for the benefit.



\*For residents who moved to the city on/after January 2, 2023 will be informed later this year.

#### National Health Insurance Tax Relief for the Antenatal and Postnatal Period has Started

If the insurance members have given birth, the amount equivalent to the period before and after childbirth is reduced from the income and per capita rate of the insurance tax.

Period: The month (or three months in the case of multiple births) before the birth (or expected birth) month to the two months after the month.

Eligibilities: National Health Insurance members who have given birth or will give birth on or after November 1, 2023. This covers births (including stillbirths, miscarriages and premature births) of 85 days' gestation or more.

**Application:** Bring the following items directly to the National Health Insurance Division.

Maternal and Child Health Handbook Boshi Kenkou Techou (or doctor's certificate or other document in case of stillbirth, miscarriage, etc..) ●IDs or certificates of the head of household and the birth mother's *My Number* 

Note: The program will take effect on January 1, 2024, so the period from January 2024 will be covered.
