

# Tax Payment

## [Deadline for Tax payment]

The deadline for tax payments is on the last day of the tax payment period, which usually falls towards the end of the month. In the case it falls on a Saturday, Sunday, or national holiday, the next available weekday is set as the due date for the tax payments.

# Municipal Tax Payment Methods

## ■ Outline

Municipal Taxes can be paid through financial institutions (including the Japan Post Bank “*Yucho Ginko*” and Post Office), Convenience Stores (includes MMK installation stores), Tax Collection Division “*Shunou-Ka*” at city hall, or at the counters of the Service Centers and Community “*Gyousei*” Centers (excludes Ota Community “*Gyousei*” Center). Account transfers are also available at your convenience.

## ■ Method of Payment

Please bring the Tax Payment Notification that you received in the post mail from Ota City, and make the payment (cash only) directly at the Tax Collection Division in Ota City Hall or at a financial institution. Municipal Taxes can also be paid at the Service Centers or Community “*Gyousei*” Centers (excludes Ota Community “*Gyousei*” Center).

Other payment methods including at convenient stores in the country, or direct debit, which debits municipal taxes from a financial institution's savings account, or payment by smartphone\***Note**, are available.

**(Note: No receipt will be issued.)**

\*Payment through smart phone by reading barcodes are available including “モバイルレジ” (mobile regi),” LINE pay (invoice payment), PayPay (invoice payment), d pay (invoice payment), J-Coin pay (invoice payment), au PAY (invoice payment).

From April 2024 onwards, you came use Rakuten pay.
