# Free School Lunch Program

The municipal schools in Ota City provide students a well-balanced, delicious lunch "Kyushoku" to promote healthy growth. School lunches are completely free of charge for students attending municipal elementary and junior high schools without any application.

## School Lunch Subsidy Program

If you have a child in a non-municipal elementary or junior high school, the subsidy will be provided by the city's e-money "Ota-Shi Digital Kinken," and in this case, an application is required.

The amount is listed below, and the fees are provided by OTACO coins or card.

The school lunch fees a and application form is on the bottom of the page.

**Elementary School:** 45,000 yen per month **Junior High School:** 55,000 yen per month

#### Requirement (Must meet both 1. and 2.)

- 1. Registered in Ota City as residents.
- 2. Not receiving Public Assistance "Seikatsu Hogo."
