How to Sort Out



CHECK BEFORE YOU THROW

Basic Rules of Disposal at Trash Station

- ✓ Sort out your garbage correctly.
- ✓ Put out your garbage by 8:30AM on the collection day.
- ✓ Use designated trash bags for burnable and non-burnable trash, and disposal stickers for oversized trash.
- ✓ **Dispose only 1 or 2 bags* per collection.** (Approx. 2 bags per household) *Note: 1 bag means max. 45 liters for burnable and 30 liters for non-burnable.





 Trash stations are managed by local residents of your district, so please respect the rule and be responsible of your own garbage as a member of the community.



Benefit ™ Low-income Households ™ FY2024

Reiwa 6 Nendo Juten Shien Chihou Kyufukin

Requirement: Must meet both (1) and (2).

- (1) Those with a registered address in the city as of the base date (December 13, 2024).
- (2) All members of the household are exempt from (a per capita basis) resident taxation for the FY2024.

→[1] Benefits for Households Exempt from Taxation Hikazei Setai Kyufu

For Households that meet the above criteria [1] and also have children 18 years old or under (born from April 2, 2006).

→[2] Additional Benefits for Children Kodomo Kasan Kyufu

Note:

- > Households consisting only of dependents of the taxpayer are not eligible.
- Only one payment per household.
- ➤ Tax information regarding the requirement (2) is based on before the Standard Tax Cut, Teigaku Genzei, applied.
- > Households that have already received the same benefit from another municipality are not eligible.

Amount: [1] 30,000-yen per household [2] 20,000-yen per child Method:

For **[1]**: Households that have been confirmed that they have received a benefit for low-income household in FY2023 (*Kakaku Koutou Juten Shien Kyufukin*: 70,000-yen/household) or FY2024 (*Bukka Koutou Taiou Kyufukin*: 100,000-yen/household) in the city, notices (postcard) have been sent. For other households, a Confirmation Letter, *Kakuninsho*, will be sent.

For **[2]**: Households that have been confirmed to meet the requirements will receive notices in order as soon as their account numbers for the payment are confirmed.
