# Childcare Service AD Allowance



# -Hourly Use Child Care Service for 1-2 yrs. old

A new temporary child care service, Papa Mama Refresh Program, is going to start from **April 1**<sup>st</sup> **(Tue.), 2025** and parents raising children between aged 1 and 2 years old can use this service for hospital visits, weddings, funerals, taking breaks, etc. If you have any questions, please contact at the Children's Affairs Division (City Hall 3F / Counter 31).

Service provided at: Higashi-Kan, Kuai Community Center (Kuai Gyousei Center)

**Hours:** 9:00 – 17:00, Monday, Tuesday, Friday, Saturday and Sunday

(excl. year-end and new year holiday)

Age: 1 and 2 years old

Cost: 300-yen per hour (OTACO App. payment only.)

**Condition**: Must have an interview and be registered before use.

(Interviews have started from **March, 2025**.)

Number of times available: Once per week

Note: There is a limit to the number of children accepted per day.




## Child-Rearing Allowance Vidou Fuvou Teatel

If your child meets the requirements but you have not yet received the allowance, consult with the Children's Affairs Division at Ota City Hall (3F/Counter 31). For more information, please check the 2D code (An English guide is available).

**Note:** Allowance payments may be limited due to income restrictions or other reasons.

**Eligibility:** Persons raising a child up to the end of the school year in which the child turns 18 (high school age). (If a child has certain disabilities, 19 years of age or under.)



- Parents have divorced.
- Father or mother has passed away.
- Father or mother has a certain degree of disability.
   (Having a degree of disability equivalent of level 1 certified by National Pension Act.)
- Father or mother is missing.
- Abandoned by their father or mother for 1 year or over.
- Father or mother has received a Domestic Violence Protective Order by court.
- Father or mother has been arrested for over 1 year.
- Mother has conceived without getting married. (Affiliated children can also receive allowance.)
- Parents are unknown (including orphaned children).



## Child Welfare Allowance (Hidou Fukushi Teate)

If you are raising a child who falls under one of the following are entitled to a Child Welfare Allowance, so please apply at the Children's Affairs Division at Ota City Hall (3F/Counter 31). **Requirement:** Those who have been registered as residents in the city for at least three months and their children meet **one** of the following criteria.



- Children 19 years of age or under with a level 1 to 3 of the Physical Disability Certificate (Shintai Shougaisha Techou).
- Children 19 years of age or under with a Grade A1 to B1 of the Medical Treatment and Education Handbook (Ryouiku Techou).
- Children's parent or guardian (father or mother, or the person raising the children if there is no parent or guardian) has died as a result of a traffic / work accident or is in a state of certain disability and has not yet completed compulsory education.

Amount paid: 3,000 yen per child per month

(Six months' worth will be transferred to the account in the first and second half of the year.) **What to bring:** Bankbook in the applicant's name, documents that can confirm the child's situation (Physical Disability Certificate, Medical Treatment and Education Handbook or documents that can prove a traffic or work accident).

Application: Directly to the Children's Affairs Division. (Check the 2D code for more information.)

Complete Vehicle Registration & Disposal Procedures!

Owners of automobiles, light motor vehicles, bikes, e-scooter, etc. must complete the procedures of registration if you are moving out of the city. You need to complete registrations (Touroku no Henkou) to change address, etc. at their newly relocated city.

If a vehicle (incl. motor vehicle) has been sold, traded-in, etc., paperwork involving change of ownership (Meigi no Henkou) must be submitted. Paperwork involving vehicle disposal (Haisha) is required when a vehicle is no longer in use because it is broken, dismantled, etc. If vehicle owners have not done the paperwork, they will be taxed with those vehicles even if they do not (or cannot) use them any longer. Vehicle owners will be taxed as a motor/light motor vehicle tax as of April 1st, so complete procedures ASAP (i.e., any changes in information, vehicle disposal, etc.). Please contact the office below according to your vehicle (or check the 2D code) for details (incl. registration).

# **Subsidies for Spaying/Neutering of Dogs and Cats** by March 31, 2025

**How to Take Care of Dogs** 



Female / male cats: Max. of 3,000-yen per cat **Conditions:** (Not applicable for commercial purposes)

- Female dogs (registered and received a FY 2024 vaccination shot for rabies) or cats owned by the city residents
- All household members must not have any municipal taxes (incl. National Health Insurance Taxes) in arrears.

- Do not cause disturbances (smell of dog waste, loud noise, etc.) to your neighbors.
- Letting your dog loose is extremely dangerous and against the law. Never let your dog run free outside of your home.
- When walking, pick up feces and dispose of them at home.

How to Apply: Bring the Certificate of completed surgery, Shujutsu Jisshizumi Shoumeisho, bankbook and inkan-seal to the city hall (5F/Counter 54) by March 31st (Mon.), 2025.

Subsidies will not be provided for surgical procedures conducted in past fiscal years.

Provision of subsides will end once the budget meets its capacity.
