Motor Vehicle Tax (Category Base) Essential Revenue for Our Daily Lives!

- The payment deadline is on June 2nd (Monday), 2025 -

Tax payments are an essential source of revenue and cover costs for basic daily operations, including welfare, health services, public facilities. If you do not pay your taxes, our basic daily operations seize to fully function. For example, driving may become dangerous due to unpaved roads or, potholes. Please pay your taxes and help maintain our living environment.

The motor vehicle tax (category base), *Jidoushazei (Shubetsuwari*), is one of the most common taxes. These taxes are collected annually from anyone registered as an owner of a vehicle on the base date of April 1st. Individuals who do not pay cannot have their vehicle go through the mandatory automobile safety inspection, *Shaken*. Furthermore, if you file your vehicle for disposal, you will be refunded for the months it was not used.

A tax notice, *Nouzei Tsuchisho*, for your motor vehicle will be mailed to taxpayers this year on May 1st and the payment is due on **June 2nd**.

The tax can be paid with a smartphone application or by credit card through the 'eL Tax for Payment (地方税お支払サイト)' website.

General Motor Vehicle Tax (Category Base) Amounts

Tax amounts differ based on factors including vehicle usage, engine displacement, date for the first registration, etc.

*Higher-rate Motor Vehicle Tax - an approximate 15% higher motor vehicle tax will need to be paid for gasoline engine vehicles that have been newly registered on or before March 31, 2012.

Reduction / Exemption from Motor Vehicle Taxes (Category Base)

Motor vehicles used as transportation for physical or severe psychological disabilities may receive exemptions (no payment for category based motor vehicle tax required) for motor vehicle taxes by applying. Please contact your nearest Administrative Affairs and Prefectural Taxation Office or Motor Vehicle Tax Office for arrangements.

In the following cases;

• "I have received a tax notice for motor vehicle tax (category base), but I do not own the car."

 \Rightarrow The tax notice has been sent to the owner **as of April 1, 2025**. Please make sure to change the name of your car or scrap the car **by March 31**. Even if you have lent your name, you are responsible for paying the tax.

• "I have not received a tax notice for my motor vehicle tax (category base)."
⇒ If your address has changed, please contact your local Administrative Affairs and Prefectural Taxation Office or the Motor Vehicle Tax Office in order to have your tax notice forwarded to your new address.

• "I do not have enough money to pay the total tax amount at once."

 \Rightarrow Your local Administrative Affairs and Prefectural Taxation Office will accept tax payments in installments if you cannot pay the total motor vehicle tax (category base) at once. Please contact your local office for arrangements.

• "I have the money but I do not want to pay the tax."

 \Rightarrow Individuals with overdue taxes will be sent reminders and notices seeking payments as soon as possible. Individuals that do not comply will face having their property seized. This is done to maintain fairness with taxpayers who are paying their taxes.

• "I lost my tax notice."

 \Rightarrow Please contact your local Administrative Affairs and Prefectural Taxation Office or the Motor Vehicle Tax Office and the notice will be resent, or you could pay without the notice at one of the offices.
