The population census is the most fundamental statistical survey of the country, conducted with the aim of understanding the actual conditions of the population and households in Japan.

- Base date: 1st (Wednesday) of October 2025.
- Target: All individuals and households living in Japan.
- Method: A census taker will visit each household to distribute census documents from late September. If you are not at home on several occasions when the visit is made, they will leave a blue envelope in your mailbox.
- How to Submit Form: 24 hours online submission is available using 'Online Response Request (Internet Kaitou Iraisho)' form enclosed in the blue envelope. Or fill in the printed survey in the envelope and send it by mail using the reply envelope.


