

Light Motor Vehicle Tax

The Light Motor Vehicle Tax *Kei Jidoshazai* is a tax levied each year on individuals recorded (on the base date of April 1 of the year) as owning a motorized bicycle, light motor vehicle (660cc or under), special small-sized motor vehicle, or small motorbike.

- ② Since this is not a monthly-installment taxation, even in cases of changes of ownership and vehicle disposal after April 1st, the taxpayer (for the vehicle) and taxation amount for that fiscal year will not change.

Note: For vehicles with good environmental performance (electric vehicles, vehicles that meet fuel efficiency standards, etc.), the tax rate may be reduced by 25% to 75% from the above rate for one year after new registration.
