Would you like to get an Individual Number (*My-Number*) Card? Following the first phase, the second phase offers points worth up to 20,000 yen if you apply to use for your health insurance card and register for public funds receiving account.

Application: Apply either through smartphone / computer from home, or go to the "*My Na Point*" application places or the Information Management Division "*Joho Kanri-Ka*," Ota City Hall (2F / Counter 28) and process applications.

What to bring: Individual (*My-Number*) Card, PIN (4 digits), cashless payment service / method details (ID and security code), and (if registering an account to receive public funds;) something that shows the account (bankbook, etc.)

Special Benefit for Low-Income Child-Rearing Households

to support their livelihood (Please apply if you are eligible for the benefit.)

Eligibilities: Persons who fall into one of the following (1)(2).

(1) Single-Parent Household

Those who have not received a Child-Rearing Allowance "Jido Fuyo Teate" for this April because they are receiving a public pension or other benefits, or whose household finances have suddenly changed due to the effects of COVID-19 and whose income has reached the same level as that of recipients of the Child-Rearing allowance.

(2) Non-Single-Parent Household

Those who are the primary breadwinner raising a child between the ages of 16 and 18 as of the end of fiscal year 2022, and who are exempt from resident tax in the fiscal year 2022, or parents, etc. who are raising a child up to 18 years old (20 years old for Special Child-Rearing Allowance "Tokubetsu Jido Fuyo Teate" recipients) as of the end of fiscal year 2022 and whose household finances have suddenly changed as a result of COVID-19 since January 2022.

Amount: 50,000-yen per child Application Period: Until February 28 (Tuesday), 2023
Application Method: Fill out the Application Form on the city website and bring it directly to the Children

Affairs Division or send it by mail.

Note: Multiple receipt of benefits for single-parent households and non-single-parent households is not allowed. **Contact:** Ota City Hall (3F / Counter 31), Children Affairs Division "Kodomo-Ka" № 0276-47-1942

FY 2022 Temporary Special Benefit for Households Exempt from Resident Tax, etc. (100,000-yen)

A Confirmation Form "Kakuninsho" are sent to households newly exempted from residence tax for the fiscal year 2022. (However, this excludes households that received temporary special benefits for the fiscal year 2021.)

Eligible households:

(1) Households which are exempt from (a per capita portion) resident tax

Households residing in the city on the base date (June 1st (Wed.), 2022) who are exempt from resident tax for the fiscal year 2022.

(2) <u>Households with sudden changes in household income</u>

Households other than those exempt from residence tax for the fiscal year 2022 that experienced a sudden change in their household finances after January 2022 due to the impact of COVID-19, and all members of the household have an income equivalent to an exemption from residence tax (a per capita portion).

Application:

(1) Households which are exempt from (a per capita portion) resident tax

- Households in which all household members have lived in the city on / before January 1st, 2021: Please fill out and return the form "Kakuninsho" being sent. (Scheduled to be sent out sequentially from late June onward.)
- ② Households with people who moved in the city on / after January 2nd, 2021, or with people have not filed their tax return yet:

Mailed application is required. Please check the city website or call center to obtain an application form. **Note:** Please file a resident tax return for the fiscal year 2022, if you have not done yet.

(2) Households with sudden changes in household income

Please fill out the application form available at the Social Assistance Division "Shakai Shien-Ka" (Ota City Hall, South Building) or at each Community "Gyosei" Center, and submit it to the Temporary Special Benefit Center Administration by post.

Deadline: September 30th (Fri.), 2022*Note

*Note: The application will be valid if the postmark is stamped on the deadline's date.

Benefits for households exempt from resident tax for the fiscal year 2021 are also available. If you are eligible but have not yet applied, please contact us as soon as possible.

Eligibilities for Examinations:

- Stomach Cancer (ingesting of barium) individuals aged 40 and over Uterine Cervical Cancer women aged 20 and over
- ●Breast Cancer women aged 40 and over who have not had a Breast Cancer Examination in FY 2021.
- Osteoporosis (bone density) women aged between 30 and 70 years old in 5-year increments (30, 35, 40, ...)

For those who are enrolled in National Health Insurance *"Kokuho"*

The current National Health Insurance card expires on July 31st (Sun.), 2022. The insurance cards, which can be used from August 1st (Mon.), 2022, will be sent out sequentially from the end of July. (Please dispose of your old insurance cards safely, or return to the National Health Insurance Division (Ota City Hall 1F / counter 16), Community "Gyosei" Centers (excluding Ota Community Center), or East / West Service Centers.)

The insurance card and the elder beneficiary certificate "Kourei Jukyusha Shou" will be unified.

People between the ages of 70 and 74 can receive medical care with only one insurance card when visiting medical institutions, etc. The co-payment rate is 20% (30% for those with income above a certain level).

The normal expiration date is July 31st next year, but the table below shows the expiration date for the following persons.

Withdrawal: If you join your company's health insurance program, become the dependents of someone who has, etc., you need to complete the procedures to withdraw from the National Health Insurance program.

National Health Insurance Tax:

Members of the National Health Insurance are responsible for the National Health Insurance Tax. A tax amount determination notice and payment slip will be mailed to you in mid-July, so please pay by the due date.
