Follow the traffic rules and drive with a sense of "care and consideration" for others. Always drive with enough time to give priority to pedestrians at crossings.

Ride your bicycle safely and follow the rules

The proportion of bicycle accidents in Gunma Prefecture involving high school students has been the worst in the country for ten consecutive years. Remember that bicycles are light vehicles and follow the rules strictly. Get insurance for your bicycle and be prepared for it in case of for accidents, etc.

## **Enrollment/Cancellation of National Health Insurance**

Please enroll in National Health Insurance "Kokuho" if you are self-employed, agricultural worker, not employed or covered by their employer's insurance, or not enrolled in some form of medical insurance program.

Procedure Deadline: within 14 days after changes, in principle

**Note:** Please be sure to follow the procedure even if the deadline has passed.

### **Enrolling into the National Health Insurance**

If you lose your Social Insurance "Shakai Hoken" after retiring, quitting, etc., you must enroll in National Health Insurance. National Health Insurance premiums will be levied retroactively to the date of withdrawal of social insurance.

#### Please bring the following documents.

- 1) Social Insurance Withdrawal Certificate "Shakai Hoken Ridatsu Shoumeisho"
- 2) I.D. such as a Resident "Zairyu" Card, driver's license, etc.
- 3) Individual Number Card or the Notification Card



### **Canceling the National Health Insurance**

You must cancel your National Health Insurance if you start enrolling in your employer's health insurance. Dependents must also cancel if they are also covered by an employer's insurance program. If you are late canceling your National Health Insurance, you will continue receiving insurance premium bills. If you use your National Health Insurance card after losing validity, you will be responsible for refunding all fees covered

#### Please bring the following documents.

- 1) Social Health Insurance Card. etc. 2) National Health Insurance Card
- 3) I.D. such as a Resident "Zairyu" Card, driver's license, etc.
- 4) Individual Number Card or the Notification Card

## Get a rabies vaccination at a VFT.

Annual shots are required for all owners of dogs 91 days of age or older. Please make sure they receive them.

No group injections will be held this FY year.



#### Rabies vaccinations

Injection fees vary by veterinary hospital. Please contact hospitals for details.

#### Cost for Issuance of Rabies Vaccination Tag: 550-yen

Note 1: If you received an injection at a hospital that does not issue the tag, please come to the Environmental Policy Division (Ota City Hall, 5F).

Note 2: Please check the city website (scan the QR code on the right.) for more information on hospitals and other facilities that you can receive Rabies Vaccination Tags.



If your dog has not been registered yet, please register at the time of vaccination.

New Registration Fee: 3.000-ven

# ıbsidies for Spraying / Neutering of Dogs and Cats

Amount of Subsidy: 1/3 of the cost

Female dogs: maximum of 5,000-yen per dog Female / male cats: maximum of 3,000-yen per cat **Conditions** 

- Female dogs (must be registered and have received a FY 2022 vaccination shot for rabies) or female / male cats owned by Ota City residents
- All household members must not have any municipal taxes (including National Health Insurance) taxes) in arrears.

How to Apply: Bring the Certificate of Completed Surgery "Shujutsu Jisshizumi Shomeisho," bankbook and *inkan*-seal, to the city hall, Environmental Policy Division (5F / Counter 51).

Note 1: Provision of subsides will end once the budget meets its capacity.

**Note 2:** Applications will not be accepted after the deadline. (**Deadline:** March 31<sup>st</sup>, 2023)

# A Medical Welfare System

When you present the "Welfare Medical Expense Eligibility Certificate (pink card)," which are issued after the application procedure, at a medical institution (within the prefecture), you will be subsidized for the partial cost of the insured medical treatment.

If you receive medical subsidies or benefits under other schemes, these will take priority and you should complete the application procedure first.

Please use the system appropriately when visiting a medical institution under the system.

#### **Eligibility:**

Classification	Requirements
Children	Children aged 0 to 18 (first March 31 after reaching 18 years of age) (excluding those who have had a marital status)
Persons with severe	National Pension Act. Level 1
mental or physical	Special Child Rearing Allowance, etc. Level 1
disabilities	Physical Disability Certificate Level 1 to 3
(incl. older persons with severe disabilities)	Medical Treatment and Education Handbook Grade A1 to A3, B1, B2 (Children under 18), IQ 50 or under
Single perents etc	Single parents with dependent children under 18
Single parents, etc.	Children under 18 without parents

#### Persons with severe mental or physical disabilities (incl. older persons with severe disabilities)

- Eligibility criteria will change from August 1<sup>st</sup>, 2023. People with a certain income will be asked to pay for their medical expenses.
- When hospitalized, you must show the "Eligibility Certificate for Ceiling-Amount Application and Reduction of the Standard Amount of Patient Liability (Gendogaku Tekiyo Hyojun Futangaku Gengaku Ninteisho)"\* at the counter of the medical institution, otherwise you will have to pay for their own dietary therapy expenses at the time of hospitalization.

<u>Note\*:</u> The certificate is issued to those households exempt from residential taxation when they apply to their health insurance provider.
