Third Vaccination for COVID-19 in Ota City

The national government has announced its policy on the implementation of third doses of the COVID-19 vaccine. Ota City is also planning to set up a vaccination system based on the national policy.

Eligibility and frequency

One additional vaccination will be available to people 18 years of age or older who have completed their first and second vaccinations (initial vaccination) and who are, in principle, at least 8 months past the completion of the second vaccination.

Vaccination tickets

Tickets / Coupons for the third dose will be sent out in due course as soon as the second vaccination record can be verified so that the vaccination can be given 8 months (or more) after the second dose. (See the details for **Dispatch of vaccination tickets (third dose)**.)

What the city sends you:

Certificate of Vaccination for COVID-19 "Sesshu Zumisho"

(A document to prove the fact that you have been vaccinated by recording the date of vaccination and the type of vaccine given after vaccination.)

- ➤ The vaccination certificate is at the bottom where the name and address are printed.
- Printed a record of the first and second vaccinations on the form. (Only if records are available in the city.)

Vaccination Ticket "Sesshu Ken" and Pre-vaccination Screening Questionnaire "Yoshinhyo"

(Unlike the first and second vaccinations, the vaccination ticket and the questionnaire are combined.)

- > The vaccination ticket is pre-printed in the upper right-hand corner of the questionnaire.
- ➤ <u>It will no longer be printed on a sticker</u> as it was for the first and second vaccinations.
- > The dates of the first and second vaccinations and the type of vaccine used are printed on the questionnaire.

Schedule for sending tickets:

Second vaccination	Sending tickets (for third vaccination)	Third vaccination	
March 2021	Sent by November 29 th , 2021	From December 2021	
April 2021	Sent by November 29", 2021	From December 2021	

Note: Those whose second vaccination is due in May 2021 or later will be informed as soon as it is available.

Who needs to apply for the tickets

For those whose second vaccination record has been confirmed, vaccination tickets will be sent out in due course, but the following people will need to apply for a ticket to be issued.

People who need to apply:

Those who have moved into the city after their second vaccination in another municipality

➤ If you have received your second vaccination in another municipality (after having been vaccinated using a vaccination ticket issued by another municipality), and then changed your residence to Ota City, you will need to apply for the issuance of a ticket from Ota City.


Dispatch of vaccination tickets (3rd dose)

Tickets will be sent out sequentially to elderly people, etc. who have completed the second round of vaccinations. Please see the enclosed information for details on how to make an appointment, etc.

Tickets and Questionnaires (image)

Vaccination tickets are printed in the upper right-hand corner of the questionnaire. Please fill in the required information and bring it to the venue.







Those who have moved to Ota City after their second vaccination abroad

➤ If you have had your first or second vaccine overseas and then transferred your residence to Ota City, you will need to apply for an issuance of a vaccination ticket from Ota City.

Those who have not received their tickets after the sending period* (*8 months or more after the second vaccination)

➤ Even if you were registered as a resident of Ota City at the time of your second vaccination, your vaccination tickets may not have been sent to you due to reasons such as your vaccination record not being registered at a medical institution or other facilities. If you have not received your tickets by the period, please apply for one.

Those who were not vaccinated at a third vaccination site and were given a preliminary examination only "Yoshin Nomi."

➤ If, after a preliminary consultation with a doctor at a vaccination center, you have been decided not to have the vaccination, you will need to apply for a new ticket for your next vaccination.



Required documents:

1. Application form for issuing a vaccination ticket for the third vaccination (only available in Japanese)





Please submit one of the following:

- ➤ Certificate of vaccination for COVID-19 "Sesshu Zumisho" (A form with a sticker issued after vaccination.)
- ➤ Vaccination Record Certificate "Sesshu Kirokusho" (for medical personnel, etc.)
- ➤ COVID-19 Vaccination Certificate for Overseas Travel
- **3. A photocopy of I.D.** (including Resident "Zairyu" Card, Driver's License, Individual Number Card, Health Insurance Card)
